AIM and TOPICS

IMPACT WRITING FOR HORIZON 2020 RESEARCH PROPOSALS

Many scientists are not used to explicitly write down the impacts they are aiming for. By structuring the way impact is incorporated in the proposal, researchers will be more likely to succeed in convincing the evaluators.

This Impact training is meant for National Contact Points to give them the know-how to better assist researchers who are applying for Horizon 2020.

The most important rules are:

- 1. **Impact** is not just the Impact section in a proposal
- 2. **Impact** starts with defining the problem and the solution the research project will offer (the Excellence section)
- 3. All project activities, without exception, should be designed to contribute towards achieving the intended **impact** (the Implementation section)

In this $1 \frac{1}{2}$ day interactive training you will:

- Learn how to read and interpret a topic text from a policy background,
- **Get hands-on** experience with an effective exercise to use Impact as a starting point for a Horizon 2020 proposal,
- Learn how to do a Network analysis,
- Experience your unique selling point,
- Learn about cross-cutting issues that further improve a proposal (multi-actor approach, RRI aspects and others),
- **Listen** to best-practises from Horizon 2020 projects how they involve stakeholders.
