# BIO HORIZON MAIN ACTIVITIES

# **1) E-MENTORING ACTIVITIES**

#### What is e-mentoring?

In order to ensure a consistent level of NCP support, also outside Europe, a simple but tailored e-mentoring scheme will be organized. This e-mentoring scheme will be implemented on-line with the clear objective of **improving connection with ICPCs and international NCPs through** on-line tools in order to optimize the networking activities with ICPCs and at the same time to minimize the costs of this activity.

Tools to be used by Bio-NCPs: direct support of a Bio Horizon mentor by e-mails and phones, discussion groups and materials from training session uploaded onto an internal document exchange platform (registration through the web) and also dedicated webinars about SC2 and KET-B.

Several experienced beneficiaries of BioHorizon will be selected as mentors according to their expertise and the list of them will be available on the exchange platform for all Bio-NCPs. In parallel, these experienced NCPs will assess the results of the benchmarking report in order to identify the needs of the non-experienced NCPs as well as ICPCs NCPs and offer them the opportunity of exchanging experience in selected issues. Thus, non-experienced Bio-NCPs and ICPC NCPs will have the possibility to select and to be supported by mentors from BioHorizon. E-mentor facilitates information and knowledge by transferring expertise without the constraints of time, or space. E-mentoring activities will be implemented during the whole duration of the project.

### Who can take part to the e-mentoring?

Everybody! E-mentoring is especially tailored for the European NCPs as well as ICPCs NCPs. It is a real occasion to reinforce your skills and to gain experience from experienced Bio-NCPs. E-mentoring will allow you to follow and record regularly your progress.

## 2) NCPs' SELF-ASSESSMENT

### What is the Benchmarking and who can use it?

Benchmarking is an online survey addressing Bio-NCPs and KET–B including Bio-NCPs from ICPCs, conducted under the framework of Bio-Horizon project. It provides to all Bio-NCPs the opportunity to self-assess their capacity through an online and easy to use benchmarking tool developed by FORTH / PRAXI Network.

#### What does the tool do?

The tool allows anonymous benchmarking of each participating NCP. It maps the existing experience of the respective NCPs, evaluates the capacity, assists with identifying areas for improvement and offers statistics in order to fully assess the strengths, weaknesses and areas for improvement of the SC2 NCPs. The outcome of the survey is a valuable tool for providing better services to clients. The Benchmarking Tool is more than a simple questionnaire that can give graphs and simple statistics. Its main purpose is to assist NCPs understand its performance vis-a-vis their peers, achieved through a database of answers provided by all users. The NCP, after having completed the questionnaire, receives a standard benchmarking report.

### **3) BIO-NCP BEST PRACTICES**

Best practice guidelines are being set up in order to help you to become a more efficient Bio-NCP. They will consist in references to be adopted for a better NCP activity performance by providing advice and recommendations. They will be available by the beginning of 2016. BioHorizon is also preparing a contest for NCP Best practices, which will reward the NCPs with the better level or the better progression by the end of the BioHorizon project. NCPs will have to apply advices and recommendations provided by the guidelines as well as to implement the knowledge gained during the staff exchanges/training sessions, in order to have a chance to win one of the prizes.

# **4) STAFF EXCHANGES**

BioHorizon is also organizing Staff Exchanges during which NCPs can visit NCPs from other countries. Staff Exchange (SE) provides a lot of opportunities for knowledge sharing and transfer of best practices. Staff Exchange Programme is the best way to learn on site and by practicing from the first hand. The host organization will show its workplace, explain how it works for Horizon 2020 Programme, give some advices and explain the difficulties to overcome. It lasts 2 days maximum and can include a field trip to a successful organization, institute, or university. Around 60 NCPs are foreseen to take part in the Staff Exchange Programme and each tour will be for 4-6 people maximum. So, 12 rounds of Staff Exchange is planned to be organized during the lifecycle of the BioHorizon. All Bio-NCPs around the world can join the Staff Exchange and it is possible to reimburse travel expenses for EU MS and AC counties in line with the reimbursement rules stated in Guidelines for Bio-NCPs. Once the host country for SE is determined, we will send an invitation mail to all Bio-NCPs for registration of the SE together with the draft programme and SE Form. You can easily register to the relevant SE by filling in the Staff Exchange Form for visiting NCPs and send it back to us.
